Tavoite:

Osallistujat oppivat luentojen, tapauselostusten ja ryhmäkeskustelujen avulla:

1. tunnistamaan koodauksessa ja käyttäytymisessä näkyviä kompleksisen trauman ja dissosiaation merkkejä Rorschachissa ja sijoittamaan ne kliinisiin –kehitykselliseen viitekehykseen, joka auttaa ymmärtämään näiden potilaiden usein tuottamaa kaaosta.
2. erottamaan traumahäiriöt psykoottisista ja rajatilahäiriöistä. käyttämällä sekvenssi- ja sisältöanalyysia sekä koodauksia
3. tunnistamaan ja käsittelemään terapeuttisesti tällaisissa tutkimuksissa luonnostaan kehittyviä traumaattisia ja dissosiativisia transferensseja ja vastatransferensseja.
4. laatimaan Rorschachin sekvenssianalyysin pohjalta hoitosuosituksia, jotka ottavat huomioon tutkittavan vahvuudet ja vaikeudet.

Judith Armstrong, Ph.D. has been a pioneer in the assessment and treatment of severe trauma and dissociation. She created the first U.S.A. Trauma and Reasearch Assessment Program in the 1970's at Baltimore's Sheppard Pratt Hospital and began her career writing, teaching and doing collaborative assessment and treatment with such patients. She has published over 30 research grounded articles and given over 40 presentations on the ways that projective measures, especially the Rorschach, help clarify the underlying personality structure, psychological strengths and vulnerabilities and differential diagnoses of people who were traumatized and traumatically neglected during their developmental years. Her clinical writings on trauma and dissociation include delineating the forms of traumatic countertransference and ways to structure trauma assessments so that they are therapy enhancing, not secondarily traumatizing, to patients and assessors. Her trauma work has won awards from the International Society of Trauma and Dissociation, Society of Personality Assessment and the Trauma division of the American Psychological Association. At present Dr. Armstrong is a Clinical Associate Professor of Psychology at the University of Southern California and in private practice consulting with therapists, patients and law firms on trauma and creative narrative building.
